
My one regret is that I did not take greater advantage of the courses offered by the history and government departments.

75; daughter Elena now a sophomore in college).



The most important thing to happen to me at Cornell was to become involved in the anti-war movement, the Cornell Committee on U.S.-Latin American Relations and other forms of political engagement that ultimately transformed my life. The stimulus for this change came from the friends I made outside the classroom. Alas, had I relied on my professors and the material they taught to inspire me to social or political activism,

I probably would have graduated as the same complacent conformist I was when I arrived on campus in the fall of 1963.

Fortunately, Cornell in the mid-1960s was a place where radical rethinking was possible -- at least in the Straight, if not in the classroom. This is the Cornell that I remember fondly. Even today, wherever I travel, I still encounter friends from that "other Cornell" -- people who are just as interesting now as then.

What I remember less fondly from student days is the profound institutional sexism that we barely questioned. I am truly shocked when I consider the limitations imposed on women -- the curfews, housing quotas, and other forms of exclusion -- that we largely accepted as normal and natural. Only a few brave souls -- male and female -- even questioned this systematic discrimination. Amazing!





It's been a fortunate life since Cornell. I went out west to Stanford and took on (1) a Master's degree in mechanical engineering and (2) a wife, Leta. It being 1968 and me not too anxious to explore Uncle Sam's alternate arrangements, I got accepted into Air Force OCS and also was offered a commission in the Public Health Service, but ultimately went to work as an engineer (that's spelled "d-e-f...") at Pratt & Whitney Aircraft in Hartford.

Had four years full of technical challenges and big-company frustration. At the ripe old age of 26 (mine), Leta and I decided to both to return to graduate school at Stanford, with son

Joel, 1, in tow. I lateraled into materials science and engineering, and Leta entered the Ph.D. program in musicology. With both of us in classes, I was sure that any quarter our schedule would have us passing Joel like a relay-race baton between classes, but it never quite came to that.

I finished up the Ph.D. in 1975 and stayed on at Stanford as a Research Associate, building on work I had done at the Electric Power Research Institute the summer before. One thing led to another, and pretty soon I had a major contract from the Dept. of Energy, which required Stanford to put me on the faculty as a non-tenure track "research" professor in materials. I stayed on in that capacity for another 15 years. Lots of opportunity to exercise "freedom with responsibility" in research topics and in getting the funding to pursue them, respectively.

The research started with deformation modelling in metals, and led into fracture modelling in metals and ceramics, deformation in polymer-matrix composites, and eventually into improved manufacturing processes for fiber composites. I supervised 17 Ph.D. students, a reward unto itself. But about that time national manufacturing competitiveness had become an important national need, and it was becoming increasingly clear that it was going to be difficult to contribute to it from a university. So once more (1990) I bolted academia, this time for the Lockheed Palo Alto Research Labs across the road. A little less freedom, about the same responsibility, but perhaps the opportunity to see some of the output turned into useful reality. We'll see. For the moment, I'm also

still involved at Stanford finishing up the last of the Ph.D. students.
